

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Department of Education Child Care & Development Fund  
Discretionary Carry Forward Budget)**

**RESOLUTION NO. 19-167**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Grants and Contracts Office has identified**  
8 **Department of Education Child Care & Development Fund Discretionary Carry**  
9 **Forward funds in the amount of \$1,224,734.69; and**

10 **WHEREAS, the Department of Education has prepared and submitted for review and**  
11 **approval its FY 2019 Department of Education Child Care & Development Fund**  
12 **Discretionary Carry Forward Budget; and**

13 **WHEREAS, the Education Department Child Care Program has prepared and submitted for**  
14 **review and approval its FY 2019 Child Care & Development Fund Discretionary**  
15 **Carry Forward Budget, which is incorporated by this reference, in the total**  
16 **amount of \$1,224,734.69; and**

17 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
18 **reviewed the FY 2019 Education Department Child Care & Development Fund**  
19 **Discretionary Carry Forward Budget and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2019 Education Department Child Care & Development Fund Discretionary**  
22 **Carry Forward Budget in the amount of \$1,224,734.69.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
24 **Nation chairperson or any designated official is authorized to administer and**  
25 **expend the FY 2019 Education Department Child Care and Development Fund**  
26 **Discretionary Carry Forward Budget, provided however, that any amendments or**  
27 **modifications shall be submitted for prior approval by the Tohono O'odham**  
28 **Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>**  
30 **day of MAY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**  
31 **AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**  
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
35 **18, 1934 (48 Stat.984).**


