

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Legislative Branch Budget Amendment No. 1)**

**RESOLUTION NO. 19-169**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Legislative Branch Budget in the amount of \$3,920,926.02 was**  
8 **approved by Resolution No. 18-298; and**

9 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its FY**  
10 **2019 Budget Amendment No. 1, which is incorporated by this reference and which**  
11 **will adjust operational and/or personnel line items; and**

12 **WHEREAS, the FY 2019 Legislative Branch Budget Amendment No. 1 will not change the**  
13 **overall budget amount of \$3,920,926.02; and**


14 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 Legislative Branch**  
15 **Budget Amendment No. 1 and recommends its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
17 **FY 2019 Legislative Branch Budget Amendment No. 1 effective October 1, 2018,**  
18 **which will not change the overall budget amount.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
20 **Legislative Council chairperson or any designated official is authorized to**  
21 **administer and expend the FY 2019 Legislative Branch Budget as amended,**  
22 **provided that any modifications shall be submitted to the Budget and Finance**  
23 **Committee for approval on behalf of the Legislative Council and amendments**  
24 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup>**  
26 **day of MAY, 2019 at a meeting at which a quorum was present with a vote of 2,591.9 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and 492.7 [09] ABSENT, pursuant to the powers vested in the Council**  
28 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**  
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
31 **Act of June 18, 1934 (48 Stat.984).**
