

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Amendment No. 1 to the Intergovernmental Agreement between Arizona**  
**Department of Economic Security and the Tohono O'odham Nation)**

**RESOLUTION NO. 19-175**

1 **WHEREAS,** the Tohono O'odham Legislative Council vests the Legislative Council with the  
2 power "to consult, negotiate, and conclude agreements and contracts on behalf  
3 of the Tohono O'odham Nation with Federal, State, and local governments and  
4 other Indian tribes . . ." and "to promote, protect and provide for public health,  
5 peace, morals, education and general welfare of the Tohono O'odham Nation and  
6 its members" (Constitution, Article VI, Section 1(f) and Section 1(c)(2)); and

7 **WHEREAS,** as approved by Resolution No. 18-486, the Tohono O'odham Nation and the  
8 Arizona Department of Economic Security entered into an Arizona Department of  
9 Economic Security Planned Social Services Block Grant Title XX FY 2019  
10 Intergovernmental Agreement ("Agreement") with a reimbursement ceiling of  
11 \$101,693.00 for a period of July 1, 2018 to June 30, 2019; and

12 **WHEREAS,** the parties now seek to execute Amendment No. 1 to the Agreement for the  
13 purpose of amending certain provisions of the FY 2019 Department of Education  
14 Child Care Services Title XX Budget, which was approved by Resolution No. 18-  
15 231, while not changing the overall budget amount of \$101,693.00; and

16 **WHEREAS,** the Human Resources Development Committee has reviewed Amendment No. 1  
17 to the Agreement and recommend its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves  
19 Amendment No. 1 to the Intergovernmental Agreement between the Arizona  
20 Department of Economic Security and the Tohono O'odham Nation, in  
21 substantially the form attached, and authorizes the Nation's chairman to execute  
22 Amendment No. 1 to the Agreement.

23 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup>  
24 day of MAY, 2019 at a meeting at which a quorum was present with a vote of 2,827.7 FOR; -0-  
25 AGAINST; [02] NOT VOTING; and 256.9 [05] ABSENT, pursuant to the powers vested in the Council  
26 by Article VI, Section 1(f) and Section 1(c)(2) of the Constitution of the Tohono O'odham Nation,  
27 adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy  
28 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the  
29 Act of June 18, 1934 (48 Stat.984).
