

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Bureau of Indian Affairs Judicial Branch P.L. 93-638
Budget Amendment No. 1 to include FY 2018 Carry Forward Savings)

RESOLUTION NO. 19-177

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation ... and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Bureau of Indian Affairs Budgets under the P.L. 93-638 Master**
8 **Contract was approved by Resolution No. 18-299, which includes the FY 2019**
9 **Judicial Branch P.L. 93-638 Budget in the amount of \$482,787.93; and**

10 **WHEREAS, the Financial Status Report, identifies FY 2018 carry forward saving in the amount**
11 **of \$114,609.24; and**

12 **WHEREAS, the Judicial Branch has prepared and submitted for review and approval its FY**
13 **2019 Bureau of Indian Affairs Judicial Branch P.L. 93-638 Budget Amendment No.**
14 **1, which is incorporated by this reference and which will adjust operational**
15 **and/or personnel line items and add new line items; and**

16 **WHEREAS, the FY 2019 Bureau of Indian Affairs Judicial Branch P.L. 93-638 Budget**
17 **Amendment No. 1 will increase the budget by \$38,430.03 from \$482,787.93 to**
18 **\$521,217.96; and**

19 **WHEREAS, the Judiciary and Budget and Finance Committees have reviewed FY 2019 Bureau**
20 **of Indian Affairs Judicial Branch P.L. 93-638 Budget Amendment No. 1 and**
21 **recommend its approval.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
23 **FY 2019 Bureau of Indian Affairs Judicial Branch P.L. 93-638 Budget Amendment**
24 **No. 1, which includes a \$38,430.03 increase from \$482,787.93 to \$521,217.96 that**
25 **shall be funded by FY 2018 P.L. 93-638 carry forward savings.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Chief Judge or any**
27 **designated official is authorized to administer and expend the FY 2019 Bureau of**
28 **Indian Affairs Judicial Service P.L. 93-638 Budget as amended, provided that any**
29 **amendments or modifications shall be submitted for prior approval by the**
30 **Tohono O'odham Legislative Council.**




