

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Casa Grande Clinic Budget)

RESOLUTION NO. 19-179

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation (the "Nation") received a Fidelity Charitable Grant**
8 **check, in honor of Richard Ramirez-bad, former Executive Office Governmental**
9 **Affairs Assistant, for \$100,000.00 designated to be used for the Casa Grande ("CG")**
10 **Clinic Project; and**

11 **WHEREAS, the Planning and Economic Development Department has prepared and**
12 **submitted for review and approval its FY 2019 CG Clinic Budget, in the amount of**
13 **\$100,000.00 to be funded by the Fidelity Charitable Grant in honor of Richard**
14 **Ramirez-bad that will be used to help the Nation establish the Casa Grande Clinic;**
15 **and**

16 **WHEREAS, the Health and Human Services, Appropriations, Commerce, Agricultural and**
17 **Natural Resources and Budget and Finance Committees have reviewed the FY**
18 **2019 CG Clinic Budget and recommend approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2019 CG Clinic Budget, effective October 1, 2018 in the amount of \$100,000.00,**
21 **which shall be funded by the Fidelity Charitable Grant in honor of Richard**
22 **Ramirez-bad that will be used to help the Nation establish the Casa Grande Clinic.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation Chairperson or any designated official is authorized to administer and**
25 **expend the FY 2019 CG Clinic Budget, provided that any amendments or**
26 **modifications required by the budget shall be submitted for prior approval by the**
27 **Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH**
29 **day of MAY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
32 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
