

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Membership Services Enrollment Program
Enhanced Tribal Card Budget)**

RESOLUTION NO. 19-185

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Membership Services has prepared and submitted for review
8 and approval its FY 2019 Enrollment Program Enhanced Tribal Card ("ETC")
9 Budget, which is incorporated by this reference, in the amount of \$289,068.36,
10 which shall be funded by the Nation's general fund surplus; and

11 **WHEREAS,** the Rules, Domestic Affairs, Cultural Preservation, and Budget and Finance
12 Committees have reviewed the FY 2019 Department of Membership Services
13 Enrollment Program ETC Budget and recommend its approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council accepts and
15 approves the FY 2019 Department of Membership Services Enrollment Program
16 ETC Budget effective October 1, 2018 in the amount of \$289,068.36, which shall be
17 funded by the Nation's general fund surplus.

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
19 Nation chairperson or any designated official is authorized to administer and
20 expend the FY 2019 Department of Membership Services Enrollment Program
21 ETC Budget, provided that any amendments or modifications shall be submitted
22 for prior approval by the Tohono O'odham Legislative Council.

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 24TH**
24 **day of MAY, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0-**
25 **AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
26 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat.984).**
