

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adjusting Apportionment of Tohono O'odham Legislative Council Votes in
Accordance with Election Board's Certification of District Residents)

LEGISLATIVE ORDER NO. 19-190

1 **WHEREAS,** Article V, Section 2 of the Constitution of the Tohono O'odham Nation provides
2 that votes cast by Legislative Council representatives shall be apportioned as
3 follows:

4 Each district shall be entitled to as many votes on the Tohono
5 O'odham Council (divided by ten) as there are members of the
6 Tohono O'odham Nation residing in the district. Such votes may
7 be cast by either or both of the district representatives, or their
8 alternates, who are present and voting.

9 ; and

10 **WHEREAS,** pursuant to 12 T.O.C. Chapter 1 – Elections, Section 1801(B) “Certification of
11 District Residents: It shall be the duty of the Board to certify from the official
12 Membership Roll of the Nation, the number of members of the Nation residing in
13 each district, and the number of votes each district is entitled to cast at the
14 Council in accordance with Article V, Section 2 of the Constitution.”; and

15 **WHEREAS,** on May 25, 2019, the Tohono O'odham Election Board conducted a general
16 election for the representatives and alternates to the Tohono O'odham
17 Legislative Council and district councils; and

18 **WHEREAS,** on May 25, 2019, the Election Board issued its Certificates of Election Results in
19 accordance with 12 T.O.C. Chapter 1, Section 1806(J); and

20 **WHEREAS,** the Election Board certified and posted its certificate of district residents and
21 district votes, entitled “Certification of District Residents,” dated May 25, 2019,
22 apportioning the number of votes each district is entitled to cast at the Tohono
23 O'odham Legislative Council (12 T.O.C. Chapter 1, Section 1801(B)); and

24 **WHEREAS,** the number of Legislative Council votes apportioned and certified by the Election
25 Board in its “Certification of District Residents” totals 3175.7; and

26 **WHEREAS,** the five-day period for appealing the number of votes given to each district by the
27 Election Board has expired and no such appeal has been filed in accordance with
28 the requirements of 12 T.O.C. Chapter 1 – Elections, Section 1801(B).

29 **NOW, THEREFORE, BE IT ORDERED** that the Tohono O'odham Legislative Council accepts the
30 apportionment of votes each district is entitled to cast at the Tohono O'odham
31 Legislative Council in accordance with the Election Board's “Certification of
32 District Residents” dated May 25, 2019 and directs the Legislative Council


1 secretary to adjust Legislative Council votes accordingly effective upon the
2 Council's issuance of certificates of election pursuant to Section 1808 of 12 T.O.C.
3 Chapter 1 - Elections.

4 The foregoing Order was passed by the Tohono O'odham Legislative Council on the 14TH day of
5 JUNE, 2019 at a meeting at which a quorum was present with a vote of 3,084.6 FOR; -0- AGAINST;
6 -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Article V,
7 Section 2 and Article VI, Section 1(g) of the Constitution of the Tohono O'odham Nation, adopted
8 by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy
9 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the
10 Act of June 18, 1934 (48 Stat.984).
