

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Department of Health and Human Services BIA**  
**Family Preservation Budget Amendment No. 1)**

**RESOLUTION NO. 19-202**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Health and Human Services BIA Family Preservation**  
8 **Budget in the amount of \$312,069.00 was approved by Resolution No. 18-299; and**

9 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
10 **review and approval its FY 2019 BIA Family Preservation Budget Amendment No.**  
11 **1, which is incorporated by this reference and which will adjust operational**  
12 **and/or personnel line items; and**

13 **WHEREAS, the FY 2019 Department of Health and Human Services BIA Family Preservation**  
14 **Budget Amendment No. 1 will increase the FY 2019 BIA Family Preservation**  
15 **Budget by \$109,155.89 from \$312,069.00 to \$421,224.89; and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
17 **reviewed the FY 2019 Department of Health and Human Services BIA Family**  
18 **Preservation Budget Amendment No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **FY 2019 Department of Health and Human Services BIA Family Preservation**  
21 **Budget Amendment No. 1 effective October 1, 2018 in the amount of \$421,224.89**  
22 **that shall be funded by the Nation's general fund pending reimbursement from**  
23 **the BIA agency.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
25 **Nation chairperson or any designated official is authorized to administer and**  
26 **expend the FY 2019 Department of Health and Human Services BIA Family**  
27 **Preservation Budget as amended, provided that any amendments or**  
28 **modifications shall be submitted for prior approval by the Tohono O'odham**  
29 **Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup>**  
31 **day of JUNE, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**  
32 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
33 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
36 **18, 1934 (48 Stat.984).**
