

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2020 Department of Education One Stop Division PY19/FY20 Budgets)**

**RESOLUTION NO. 19-204**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section I(d)(2)); and**

7 **WHEREAS, the Arizona Department of Economic Security Workforce Innovation and**  
8 **Opportunity Act ("WIOA") Title 1B, Intergovernmental Agreement ("IGA") was**  
9 **approved by Resolution No. 15-441; and**

10 **WHEREAS, the Arizona Department of Economic Security has granted the Tohono O'odham**  
11 **Nation Department of Education One Stop Division the amount of \$484,483.00 for**  
12 **the period beginning on July 1, 2019 through June 30, 2020; and**

13 **WHEREAS, the Department of Education has prepared and submitted for review and**  
14 **approval its FY 2020 One Stop Division PY19/FY20 Budgets, which are**  
15 **incorporated by this references, in the total amount of \$484,483.00:**

31 **general fund pending reimbursement from the Arizona Department of Economic**  
32 **Security.**


