

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2020 Tohono O'odham Nation Department of Health and Human  
Services Senior Services Program Title III Budgets)**

**RESOLUTION NO. 19-207**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**  
8 **review and approval its FY 2020 Senior Services Program Title III Budgets, which**  
9 **are incorporated by this reference:**

(2)	Title III C-1 Congregate Budget	\$38,592.50

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**  
18 **reviewed the FY 2020 Department of Health and Human Services Senior Services**  
19 **Program Title III Budgets and recommend their approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
21 **FY 2020 Department of Health and Human Services Senior Services Program Title**  
22 **III Budgets effective July 1, 2019, in the total amount of \$106,992.50 which shall be**  
23 **funded by the Nation's general fund pending reimbursement by the grantor, Title**  
24 **III of the Older Americans Act through the Inter-Tribal Council of Arizona.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
26 **Nation chairperson or any designated official is authorized to administer and**  
27 **expend the FY 2020 Department of Health and Human Services Senior Services**  
28 **Program Title III Budgets, provided that any amendments or modifications shall**  
29 **be submitted for prior approval by the Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18<sup>TH</sup>**  
31 **day of JUNE, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**  
32 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**  
33 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
36 **18, 1934 (48 Stat.984).**
