

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Planning Department Credit and Finance Program BIA P.L.
93-638 Budget Amendment No. 1)**

RESOLUTION NO. 19-217

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Planning Department Credit and Finance Program BIA P.L. 93-638**
8 **Budget in the amount of \$301,378.43 was approved by Resolution No. 18-299; and**

9 **WHEREAS, the Planning Department has prepared and submitted for review and approval**
10 **its FY 2019 Credit and Finance Program BIA P.L. 93-638 Budget Amendment No. 1,**
11 **which is incorporated by this reference and which will adjust operational line**
12 **items; and**

13 **WHEREAS, the FY 2019 Planning Department Credit and Finance Program BIA P.L. 93-638**
14 **Budget Amendment No. 1 will increase the FY 2019 Planning Department Credit**
15 **and Finance Program BIA P.L. 93-638 Budget by \$221,456.44 from \$301,378.43 to**
16 **\$522,834.87; and**

17 **WHEREAS, the Commerce and Budget and Finance Committees have reviewed the FY 2019**
18 **Planning Department Credit and Finance Program BIA P.L. 93-638 Budget**
19 **Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2019 Planning Department Credit and Finance Program BIA P.L. 93-638 Budget**
22 **Amendment No. 1 effective October 1, 2018, which includes a \$221,456.44 increase**
23 **from \$301,378.43 to \$522,834.87 that shall be funded by FY 2018 Credit and**
24 **Finance Program BIA P.L. 93-638 savings.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2019 Planning Department Credit and Finance Program BIA P.L.**
28 **93-638 Budget as amended, provided that any amendments or modifications**
29 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH**
31 **day of JUNE, 2019 at a meeting at which a quorum was present with a vote of 2,936.8 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and 238.9 [03] ABSENT, pursuant to the powers vested in the Council**
33 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
34 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
35 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
36 **Act of June 18, 1934 (48 Stat.984).**
