

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019-FY 2020 Sells Dental Services Program Silver Diamine
Fluoride Project Budget)

RESOLUTION NO. 19-219

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation Health Care ("TONHC") Governing Body was**
8 **delegated the authority to review and approve all TONHC budgets and budgets**
9 **expending health self-governance funds, including budgets expending such**
10 **funds for supporting programs within other Nation's departments, subject to**
11 **Legislative Council oversight committee review and final approval by Legislative**
12 **Council resolution (Tohono O'odham Nation Health Care Governing Body Bylaws,**
13 **Section 9403 (A)); and**

14 **WHEREAS, the Tohono O'odham Nation Health Care has prepared and submitted for review**
15 **and approval its FY 2019-FY 2020 Sells Dental Services Program Silver Diamine**
16 **Fluoride ("SDF") Project Budget, which is incorporated by this reference in the**
17 **amount of \$55,000 to be funded by the Delta Dental of Arizona Foundation; and**

18 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
19 **reviewed the FY 2019-FY 2020 Sells Dental Services Program SDF Project Budget**
20 **and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2019-FY 2020 Sells Dental Services Program SDF Project Budget in the amount**
23 **of \$55,000, effective January 1, 2019, which shall be funded by the Delta Dental of**
24 **Arizona Foundation.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
26 **Nation chairperson or any designated official is authorized to administer and**
27 **expend the FY 2019-FY 2020 Sells Dental Services Program SDF Project Budget,**
28 **provided that any amendments or modifications shall be submitted for prior**
29 **approval by the Tohono O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
31 **day of JUNE, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
36 **18, 1934 (48 Stat.984).**
