

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Holding July 10, 2019 General Session at Desert Diamond West Valley Resort and Casino)**

LEGISLATIVE ORDER NO. 19-222

1 **WHEREAS, the Legislative Council is vested with the power “[t]o establish rules and**
2 **procedures to regulate all meetings of the Tohono O’odham Council, standing**
3 **committees, boards and special committees.” (Constitution of the Tohono**
4 **O’odham Nation, Article VI, Section 1(a)); and**


5 **WHEREAS, Article I, Section 2(C) of the Legislative Rules of the Tohono O’odham Legislative**
6 **Council, as amended, provides that “[a]ll Legislative Council sessions shall be**
7 **held at the Tohono O’odham Legislative Council chambers located in Sells,**
8 **Tohono O’odham Nation, with the following exceptions. . . [a] majority of all the**
9 **legislative representatives may vote to hold a session in some location other than**
10 **the chambers located at Sells.”; and**

11 **WHEREAS, the Commerce Committee has requested that the Legislative Council hold its July**
12 **10, 2019 general session at the Desert Diamond West Valley Resort and Casino.**

13 **NOW, THEREFORE, BE IT ORDERED that the Tohono O’odham Legislative Council will hold its**
14 **July 10, 2019 general session at the Desert Diamond West Valley Resort and**
15 **Casino with roll call at 10:30 a.m.**

16 **The foregoing Order was passed by the Tohono O’odham Legislative Council on the 21TH day of**
17 **JUNE, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST;**
18 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article VI,**
19 **Section 1(a) of the Constitution of the Tohono O’odham Nation, adopted by the Tohono O’odham**
20 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian**
21 **Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
22 **Stat.984).**
