

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Chukut Kuk District Budget Amendment No. 4)

RESOLUTION NO. 19-228

- 1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**
- 3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

- 12 **WHEREAS,** the FY 2019 Chukut Kuk District Budget in the amount of \$2,017,635.31 was
13 **authorized by Chukut Kuk District Council Resolution No. 2018-40 and approved**
14 **by Legislative Council Resolution No. 18-390 in the amount of \$2,017,635.31 and**
15 **subsequently amended by Legislative Council Resolution No. 18-482 in the**
16 **amount of \$2,032,635.31, Legislative Council Resolution No. 19-090 in the amount**
17 **of \$2,130,128.61 and Legislative Council Resolution No. 19-154 in the amount of**
18 **\$2,140,912.61; and**
- 19 **WHEREAS,** by Chukut Kuk District Resolution No. 2019-25, the Chukut Kuk District Council
20 **authorized and submitted for review and approval its FY 2019 Amendment No. 4,**
21 **which is incorporated by this reference, and which adjusts operational and/or**
22 **personnel line items, adds a new line item, and amends line item justification**
23 **language; and**
- 24 **WHEREAS,** the FY 2019 Chukut Kuk District Budget Amendment No. 4 will increase the FY
25 **2019 Ak Komelik Community Budget at \$15,401.16 from \$20,000.00 to \$35,401.16;**
26 **and**
- 27 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 Chukut Kuk District
28 **Budget Amendment No. 4 and recommends its approval.**
- 29 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
30 **FY 2019 Chukut Kuk District Budget Amendment No. 4, which will increase the**
31 **overall FY 2019 Chukut Kuk District Budget by \$15,401.16 from \$2,140,912.61 to**
32 **\$2,156,313.77, to be funded as follows:**
- 33 1. **Carryover FY 2016 surplus funds in the amount of \$2,736.72**
 - 34 2. **Carryover FY 2017 surplus funds in the amount of \$4,715.00**
 - 35 3. **Carryover FY 2014 Mining Royalties in the amount of \$3,896.65**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH day of JULY, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
