

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Office of the Prosecutor Budget Amendment No. 1)**

**RESOLUTION NO. 19-230**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Office of the Prosecutor Budget in the amount of \$997,974.76 was  
8 approved by Resolution No. 18-339; and

9 **WHEREAS,** the Office of the Prosecutor has prepared and submitted for review and approval  
10 its FY 2019 Budget Amendment No. 1, which is incorporated by this reference and  
11 which will adjust personnel and/or operational line items; and

12 **WHEREAS,** the FY 2019 Office of the Prosecutor Budget Amendment No. 1 does not change the  
13 original budget amount of \$997,974.76; and

14 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY  
15 2019 Office of the Prosecutor Budget Amendment No.1 and recommend its  
16 approval.

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
18 FY 2019 Office of the Prosecutor Budget Amendment No. 1, which will not change  
19 the original budget amount of \$997,974.76.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
21 Nation chairperson or any designated official is authorized to administer and  
22 expend the FY 2019 Office of the Prosecutor Budget as amended, provided that  
23 any amendments or modifications shall be submitted to the Tohono O'odham  
24 Legislative Council for prior approval.

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>**  
26 **day of JULY, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
28 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**  
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat.984).**
