

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Baboquivari District Budgets Amendments, FY 2019 South  
Komelic Budget, and FY 2019 Choulic Community Activity Budget)**

**RESOLUTION NO. 19-231**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,  
3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.  
11 ; and  
12 **WHEREAS,** the FY 2019 Baboquivari District Budget in the amount of \$3,955,217.99 was  
13 authorized by Baboquivari District Council Resolution No. 2018-B-66 and  
14 approved by Legislative Council Resolution No. 18-381, and subsequently  
15 amended by Resolution No. 19-021 in the amount of \$4,115,835.64 and by  
16 Resolution No. 19-074 which did not change the budget amount; and  
17 **WHEREAS,** by Baboquivari District Council Resolution No. 2019-B-29, the Baboquivari  
18 District Council has authorized and submitted for review and approval its FY 2019  
19 South Komelic Community Budget, which is incorporated by this reference in the  
20 amount of \$69,152.75 and which will adjust operational and/or personnel line  
21 items; and  
22 **WHEREAS,** by Baboquivari District Council Resolution No. 2019-B-35, the Baboquivari  
23 District Council has authorized and submitted for review and approval its FY 2019  
24 Baboquivari District Day Budget Amendment No. 1, which is incorporated by this  
25 reference and which will adjust operational and/or personnel line items; and  
26 **WHEREAS,** by Baboquivari District Council Resolution No. 2019-B-37, the Baboquivari  
27 District Council has authorized and submitted for review and approval its FY 2019  
28 Fresno Canyon Community Budget Amendment No. 1, which is incorporated by  
29 this reference and which increases the budget by \$45,165.57 and adjusts  
30 operational and/or personnel line items; and  
31 **WHEREAS,** by Baboquivari District Council Resolution No. 2019-B-38, the Baboquivari  
32 District Council has authorized and submitted for review and approval its FY 2019  
33 Choulic Community Budget Amendment No. 3, which is incorporated by this

reference and which decreases the budget by \$75,582.34 and adjusts operational and/or personnel line items; and

**WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 Baboquivari District Budgets and budget amendments and recommends approval.**

**NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the FY 2019 Baboquivari District Budgets and budget amendments, which includes an increase in the total FY 2019 Baboquivari District Budget by \$114,318.32 from \$4,115,835.64 to \$4,230,153.96:**

- (1) FY 2019 South Komelic Budget in the amount of \$69,152.75 that shall be funded by 2018 mining royalties: \$53,160.16 from ASARCO and \$15,992.59 from Cyprus.**
- (2) FY 2019 Baboquivari District Day Budget Amendment No. 1, which does not change the budget amount of \$20,000.00.**
- (3) FY 2019 Fresnal Canyon Budget Amendment No. 1, which includes a \$45,167.57 increase from \$377,705.65 to \$422,871.22 that shall be funded by FY 2012 carryover funds.**
- (4) FY 2019 Choulic Community Budget Amendment No. 3, which includes a \$75,582.34 decrease from \$502,157.75 to \$426,575.41 and moves these funds into the FY 2019 Choulic Home Project Budget and new FY 2019 Choulic Community Activity Budget.**
- (5) FY 2019 Choulic Home Project Budget Amendment No. 1 which includes a \$47,117.58 increase from \$48,249.92 to \$95,367.50 that shall be funded by the FY 2019 Choulic Community Budget Amendment No. 3.**
- (6) FY 2019 Choulic Community Activity Budget in the amount of \$28,464.76 that shall be funded by the FY 2019 Choulic Community Budget Amendment No. 3.**

**BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2019 Baboquivari District Budgets as amended shall be managed and expended in accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws, provided that any amendments or modifications shall be authorized under District Council resolution and submitted for prior approval by the Tohono O'odham Legislative Council.**


