

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Pisinemo District Kupk Community Mining Royalties
Budget Amendment No. 1)**

RESOLUTION NO. 19-235

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS, the FY 2019 Pisinemo District Mining Royalties Budget in the amount of**
13 **\$484,069.23 was authorized by Pisinemo District Budget Resolution No. 18-P-27**
14 **and approved by Legislative Council Resolution No. 18-388; and**

15 **WHEREAS, by Pisinemo District Council Resolution 19-P-22, the Pisinemo District has**
16 **authorized and submitted for review and approval its FY 2019 Pisinemo District**
17 **Kupk Community Budget Amendment No. 1, which is incorporated by this**
18 **reference and which will adjust operational and/or personnel line items; and**

19 **WHEREAS, the FY 2019 Pisinemo District Kupk Community Mining Royalties Budget**
20 **Amendment No. 1 will not change the original budget amount of \$96,813.85; and**

21 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 Pisinemo District**
22 **Kupk Community Budget Amendment No. 1 and recommends its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **FY 2019 Pisinemo District Kupk Community Mining Royalties Budget**
25 **Amendment No. 1 effective October 1, 2018, which will not change the original**
26 **budget amount of \$96,813.85.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2019 Pisinemo**
28 **District Kupk Community Mining Royalties Budget as amended shall be managed**
29 **and expended in accordance with Article IX, Section 7 of the Constitution of the**
30 **Tohono O'odham Nation and the Nation's laws, provided that any amendments or**
31 **modifications shall be authorized under District Council resolution and**
32 **submitted for prior approval by the Tohono O'odham Legislative Council.**


