

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the Tohono O'odham Ki:Ki Association to Submit a 2019
Competitive Indian Housing Block Grant Application)

RESOLUTION NO. 19-236

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power to enact laws "to promote, protect and provide for public health, peace,**
3 **morals, education and general welfare of the Tohono O'odham Nation and its**
4 **members" (Constitution, Article VI, Section 1(c)(2)); and**

5 **WHEREAS, the Tohono O'odham Ki:Ki Association ("TOKA") is the Nation's tribally**
6 **designated housing entity in accordance with the Native American Housing**
7 **Assistance and Self-Determination Act of 1996, 25 U.S.C. § 4101, et seq., P.L. 104-**
8 **330, 110 Stat. 4106 ("NAHASDA") and is authorized to receive and administer the**
9 **Indian Housing Block Grant ("IHBG") and to seek other funds to operate and**
10 **expand affordable housing; and**

11 **WHEREAS, the TOKA wishes to continue providing new affordable housing to meet the needs**
12 **of community members by submitting a 2019 IHBG competitive application for**
13 **\$5,000,000.00 and leveraging Indian Housing Block Grant funds for the**
14 **construction of 30 low-income new homeownership housing units to serve and**
15 **improve the quality of life for Nation's members; and**

16 **WHEREAS, the TOKA presented its 2019 IHBG competitive funding application and summary**
17 **to the Housing Committee, which recommends approval.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 19 **1. the TOKA is authorized to submit a 2019 application for IHBG competitive**
20 **funding in the amount of \$5,000,000.00 and to leverage those funds with**
21 **Indian Housing Block Grant funds to construct 30 new low-income**
22 **homeownership housing units; and**
- 23 **2. the Nation certifies and confirms that it will assume environmental**
24 **responsibilities under 24 CFR Part 58.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes and directs**
26 **the Nation's chairperson or any designated official to execute all documents**
27 **necessary for the TOKA to submit the 2019 IHBG competitive funds application,**
28 **including the environmental responsibilities under 24 CFR Part 58.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
30 **day of JULY, 2019 at a meeting at which a quorum was present with a vote of 2,911.2 FOR; -0-**
31 **AGAINST; 264.5 [02] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**
32 **by Article VI, Section 1(c)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
33 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**
