

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting Indian Health Service Data Infrastructure Funds and Approving FY 2019-FY 2020
Department of Health and Human Services Data Infrastructure Funds Budget)

RESOLUTION NO. 19-239

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Tohono O'odham Nation received a notice of award from the Indian Health**
8 **Service Tucson Area for data infrastructure funds, in the amount of \$180,000.00;**
9 **and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
11 **review and approval its FY 2019-FY 2020 Data Infrastructure Funds Budget in the**
12 **amount of \$180,000.00, which is incorporated by this reference; and**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
14 **reviewed the FY 2019-FY 2020 Department of Health and Human Services Data**
15 **Infrastructure Funds Budget and recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council**
17 **accepts the Indian Health Services Data Infrastructure Funds.**

18 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the FY 2019-**
19 **FY 2020 Department of Health and Human Services Data Infrastructure Funds**
20 **Budget effective October 1, 2018 in the amount of \$180,000.00 that shall be funded**
21 **by the grantor, Indian Health Service.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **chairperson or any designated official is authorized to administer and expend**
24 **the FY 2019-FY 2020 Department of Health and Human Services Data**
25 **Infrastructure Funds Budget, provided that any amendments or modifications**
26 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH**
28 **day of JULY, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1 (d)(2)and(3)and1(f) of the Constitution of the Tohono O'odham Nation,**
31 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
32 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
33 **Act of June 18, 1934 (48 Stat.984).**


