

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Office of the Prosecutor Tohono O'odham Victim Witness
Program Budget Amendment No. 1)

RESOLUTION NO. 19-240

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the U.S. Department of Justice, Office for Victims of Crime awarded the Tohono**
8 **O'odham Nation Office of the Prosecutor Grant Award No. 2016-VR-GX-K008 in the**
9 **amount of \$450,000.00 for a three-year period beginning October 1, 2016 and**
10 **ending September 30, 2019; and**

11 **WHEREAS, Grant Award No. 2016-VR-GX-K008 was accepted by Resolution No. 17-136; and**

12 **WHEREAS, the FY 2019 Office of the Prosecutor Tohono O'odham Victim Witness Program**
13 **Budget in the amount of \$210,014.94 was approved by Resolution No. 18-323; and**

14 **WHEREAS, the Office of the Prosecutor has prepared and submitted for review and approval**
15 **its FY 2019 Tohono O'odham Victim Witness Program Budget Amendment No. 1,**
16 **which is incorporated by reference, and which adjusts operational and/or**
17 **personnel line items; and**

18 **WHEREAS, the FY 2019 Office of the Prosecutor Tohono O'odham Victim Witness Program**
19 **Budget Amendment No. 1 does not change the budget amount of \$210,014.94; and**

20 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
21 **2019 Office of the Prosecutor Tohono O'odham Victim Witness Program Budget**
22 **Amendment No. 1 and recommend its approval.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
24 **FY 2019 Office of the Prosecutor Tohono O'odham Victim Witness Program**
25 **Budget Amendment No. 1 effective October 1, 2018, which does not change the**
26 **budget amount of \$210,014.94.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Nation chairperson or any designated official is authorized to administer and**
29 **expend the FY 2019 Office of the Prosecutor Tohono O'odham Victim Witness**
30 **Program Budget as amended, provided however, that any amendments or**
31 **modifications shall be submitted for prior approval by the Tohono O'odham**
32 **Legislative Council.**


