

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Health and Human Services Healthy
O'odham Promotion Program Budget Amendment No. 2)

RESOLUTION NO. 19-257

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2020 Department of Health and Human Services Healthy O'odham
8 Promotion Program Budget in the amount of \$2,241,130.00 was approved by
9 Resolution No. 19-041 and amended by Resolution No. 19-091 in the amount of
10 \$3,992,954.17; and

11 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
12 review and approval its FY 2020 Healthy O'odham Promotion Program Budget
13 Amendment No. 2, which is incorporated by this reference and which will adjust
14 operational and/or line items; and

15 **WHEREAS,** the FY 2020 Department of Health and Human Services Healthy O'odham
16 Promotion Program Budget Amendment No. 2 will not change the total budget
17 amount of \$3,992,954.17; and

18 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
19 reviewed the FY 2020 Department of Health and Human Services Healthy
20 O'odham Promotion Program Budget Amendment No. 2 and recommend its
21 approval.

22 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
23 FY 2020 Department of Health and Human Services Healthy O'odham Promotion
24 Program Budget Amendment No. 2 effective January 1, 2019, which will not
25 change the total budget amount of \$3,992,954.17.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
27 Nation chairperson or any designated official is authorized to administer and
28 expend the FY 2020 Department of Health and Human Services Healthy O'odham
29 Promotion Program Budget as amended, provided that any amendments or
30 modifications shall be submitted for prior approval by the Tohono O'odham
31 Legislative Council.
