

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Natural Resources Department Administration Budget
Amendment No. 1)**

RESOLUTION NO. 19-259

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Natural Resources Department Administration Budget in the amount
8 of \$634,471.79 was approved by Resolution No. 18-339; and

9 **WHEREAS,** the Natural Resources Department has prepared and submitted for review and
10 approval its FY 2019 Administration Budget Amendment No. 1, which is
11 incorporated by this reference and which will adjust an operational and/or
12 personnel line items; and

13 **WHEREAS,** the FY 2019 Natural Resources Department Administration Budget Amendment
14 No. 1 will increase the FY 2019 Natural Resources Department Administration
15 Budget by \$24,023.51 from \$634,471.79 to \$658,495.30; and

16 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
17 have reviewed the FY 2019 Natural Resources Department Administration Budget
18 Amendment No. 1 and recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 **FY 2019 Natural Resources Department Administration Budget Amendment No. 1**
21 **effective October 1, 2018, which includes a \$24,023.51 increase from \$634,471.79**
22 **to \$658,495.30 that shall be funded by the Nation's General Fund from an**
23 **insurance claim.**

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
25 Nation chairperson or any designated official is authorized to administer and
26 expend the FY 2019 Natural Resources Department Administration Budget as
27 amended, provided that any amendments or modifications shall be submitted
28 for prior approval by the Tohono O'odham Legislative Council.

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH**
30 **day of JULY, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR -0-**
31 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**
