

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Natural Resources Department Range Conservation
and Management Program Budget Amendment No. 1)

RESOLUTION NO. 19-261

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Natural Resources Department Range Conservation and**
8 **Management Program Budget in the amount of \$741,661.94 was approved by**
9 **Resolution No. 18-299; and**

10 **WHEREAS, the Natural Resources Department has prepared and submitted for review and**
11 **approval its FY 2019 Range Conservation and Management Budget Amendment**
12 **No. 1, which is incorporated by this reference and which will adjust personnel**
13 **and/or operational line items; and**

14 **WHEREAS, the FY 2019 Natural Resources Department Range Conservation and**
15 **Management Program Budget Amendment No. 1 will increase the FY 2019 Natural**
16 **Resources Department Budget by \$70,789.67 from \$741,661.94 to \$812,451.61; and**

17 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
18 **have reviewed the FY 2019 Natural Resources Department Range Conservation**
19 **and Management Program Budget Amendment No. 1 and recommend its**
20 **approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
22 **FY 2019 Natural Resources Department Range Conservation and Management**
23 **Program Budget Amendment No. 1 effective October 1, 2018, which includes a**
24 **\$70,789.67 increase from \$741,661.94 to \$812,451.61 that shall be funded by the**
25 **Bureau of Indian Affairs.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2019 Natural Resources Department Range Conservation and**
29 **Management Program Budget as amended, provided that any amendments or**
30 **modifications shall be submitted for prior approval by the Tohono O'odham**
31 **Legislative Council.**
