

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Department of Education Special Services Program**  
**Individuals with Disabilities Education Act Part C Budget Amendment No. 1)**

RESOLUTION NO. 19-265

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Department of Education Special Services Program Individuals with  
8 Disabilities Education Act ("IDEA") Part C Budget in the amount of \$77,044.73 was  
9 approved by Resolution No 18-299; and

10 **WHEREAS,** the Department of Education has prepared and submitted for review and  
11 approval its FY 2019 Special Services Program IDEA Part C Budget Amendment  
12 No. 1, which is incorporated by this reference and which will adjust operational  
13 and/or personnel line items; and

14 **WHEREAS,** the FY 2019 Department of Education Special Services Program IDEA Part C  
15 Budget Amendment No. 1 will increase the FY 2019 Department of Education  
16 Special Services Program IDEA Part C Budget by \$151,770.20 from \$77,044.73 to  
17 \$228,814.93; and

18 **WHEREAS,** the Human Resources Development and Budget and Finance Committees have  
19 reviewed the FY 2019 Department of Education Special Services Program IDEA  
20 Part C Budget Amendment No. 1 and recommend its approval.

21 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
22 FY 2019 Department of Education Special Services Program IDEA Part C Budget  
23 Amendment No. 1 effective October 1, 2018, which includes an increase of  
24 \$151,770.20 from \$77,044.73 to \$228,814.93 that shall be funded by the Nation's  
25 general fund pending reimbursement from the grantor.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
27 Nation chairperson or any designated official is authorized to administer and  
28 expend the FY 2019 Department of Education Special Services Program IDEA Part  
29 C Budget as amended, provided that any amendments or modifications shall be  
30 submitted for prior approval by the Tohono O'odham Legislative Council.
