

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Education Child Care Services Title XX
Budget Amendment No. 1)

RESOLUTION NO. 19-266

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Education Child Care Services Title XX Budget in the**
8 **amount of \$101,693.00 was approved by Resolution No. 18-231; and**

9 **WHEREAS, the Department of Education has prepared and submitted for review and**
10 **approval its FY 2019 Child Care Services Title XX Budget Amendment No. 1, which**
11 **is incorporated by this reference and which will adjust operational and/or**
12 **personnel line items; and**

13 **WHEREAS, the FY 2019 Department of Education Child Care Services Title XX Budget**
14 **Amendment No. 1 will not change the total budget amount of \$101,693.00; and**

15 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
16 **reviewed the FY 2019 Department of Education Child Care Services Title XX**
17 **Budget Amendment No. 1 and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2019 Department of Education Child Care Services Title XX Budget**
20 **Amendment No. 1 in the amount of \$101,693.00, which shall be funded by the**
21 **Nation's general fund pending reimbursement from the grantor for the**
22 **continuation of the grant.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2019 Department of Education Child Care Services Title XX Budget**
26 **as amended, provided that any amendments or modifications shall be submitted**
27 **for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH**
29 **day of JULY, 2019 at a meeting at which a quorum was present with a vote of 3,057.9 FOR 117.8**
30 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
