

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Education Administration Budget Amendment No. 1)

RESOLUTION NO. 19-267

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Education Administration Budget in the amount of**
8 **\$578,793.50 was approved by Resolution No. 18-339; and**

9 **WHEREAS, the Department of Education has prepared and submitted for review and**
10 **approval its FY 2019 Administration Budget Amendment No. 1, which is**
11 **incorporated by this reference and which will adjust operational and/or**
12 **personnel line items; and**

13 **WHEREAS, the FY 2019 Department of Education Administration Budget Amendment No. 1**
14 **will not change the original budget amount of \$578,793.50; and**

15 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**
16 **reviewed the FY 2019 Department of Education Administration Budget**
17 **Amendment No. 1 and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
19 **FY 2019 Department of Education Administration Budget Amendment No. 1**
20 **effective October 1, 2018, which will not change the original budget amount of**
21 **\$578,793.50.**

22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
23 **Nation chairperson or any designated official is authorized to administer and**
24 **expend the FY 2019 Department of Education Administration Budget as**
25 **amended, provided that any amendments or modifications shall be submitted**
26 **for prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH**
28 **day of JULY, 2019 at a meeting at which a quorum was present with a vote of 3,057.9 FOR 117.8**
29 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat.984).**
