

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Office of Attorney General Budget Amendment No. 1)**

RESOLUTION NO. 19-270

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Office of Attorney General Budget in the amount of \$2,588,020.72 was**
8 **approved by Resolution No. 18-339; and**

9 **WHEREAS, the Office of Attorney General has prepared and submitted for review and**
10 **approval its FY 2019 Budget Amendment No. 1, which is incorporated by this**
11 **reference and which will adjust operational and/or personnel line items; and**

12 **WHEREAS, the FY 2019 Office of Attorney General Budget Amendment No. 1 will not change**
13 **the original budget amount of \$2,588,020.72; and**

14 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed the FY**
15 **2019 Office of Attorney General Budget Amendment No. 1 and recommend its**
16 **approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2019 Office of Attorney General Budget Amendment No. 1 effective October 1,**
19 **2018, which will not change the original budget amount of \$2,588,020.72.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2019 Office of Attorney General Budget as amended, provided that**
23 **any amendments or modifications shall be submitted for prior approval by the**
24 **Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH**
26 **day of JULY, 2019 at a meeting at which a quorum was present with a vote of 3,057.9 FOR 117.8**
27 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**
