

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Natural Resources Solid Waste
Management Program Amendment No. 1)

RESOLUTION NO. 19-272

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Natural Resources Solid Waste Management Program**
8 **in the amount of \$2,060,519.48, \$1,650,519.48 which is funded by the Nation's**
9 **general fund approved by resolution 18-339, and \$410,000.00 which is funded by**
10 **program revenue and approved by Resolution No. 18-317; and**

11 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**
12 **approval its FY 2019 Solid Waste Management Program Budget Amendment No.**
13 **1, which is incorporated by this reference and which adjusts personnel and/or**
14 **operational line items; and**

15 **WHEREAS, the FY 2019 Department of Natural Resources Solid Waste Management Program**
16 **Budget Amendment No. 1 will increase the FY 2019 Department of Natural**
17 **Resources Solid Waste Management Program Budget Amendment No. 1 by**
18 **\$130,000.00 from \$2,060,519.48 to \$2,190,519.48, which shall be funded by the**
19 **dedicated revenue account for the deposit of funds received by the Department**
20 **of Natural Resources Solid Waste Management Program; and**

21 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
22 **have reviewed the FY 2019 Department of Natural Resources Solid Waste**
23 **Management Program Budget Amendment No. 1 and recommend its approval.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
25 **FY 2019 Department of Natural Resources Solid Waste Management Program**
26 **Budget Amendment No. 1, which includes a \$130,000.00 increase from**
27 **\$2,060,519.48 to \$2,190,519.48 that shall be funded by the dedicated revenue**
28 **account for the deposit of funds received by the Department of Natural Resources**
29 **Solid Waste Management Program.**

30 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
31 **Nation chairperson or any designated official is authorized to administer and**
32 **expend the FY 2019 Department of Natural Resources Solid Waste Management**
33 **Program Budget as amended, provided that any amendments or modifications**
34 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**
