

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Tohono O'odham Nation Health Care Budget Amendments)**

RESOLUTION NO. 19-273

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation Health Care ("TONHC") Governing Body was
8 delegated the authority to review and approve all TONHC budgets and budgets
9 expending health self-governance funds, including budgets expending such
10 funds for supporting programs within other Nation's departments, subject to
11 Legislative Council oversight committee review and final approval by Legislative
12 Council resolution (Tohono O'odham Nation Health Care Governing Body Bylaws,
13 Section 9403 (A)); and

14 **WHEREAS,** the FY 2019 Tohono O'odham Nation Health Care Budgets for the Tohono
15 O'odham Nation Health Care, Department of Public Safety-Health Care Center
16 Security, Department of Information and Technology-Third Party, Facility
17 Management Program, and Planning and Economic Development Department in
18 the amount of \$134,763,439.11 was approved by Resolution No. 18-344; and

19 **WHEREAS,** the Tohono O'odham Nation Health Care has prepared and submitted for review
20 and approval the following FY 2019 Tohono O'odham Nation Health Care Budget
21 Amendments Table, as dated for reference July 2019, which is incorporated by
22 this reference and which identifies the budget amendments and amended totals:

3 **2019 Tohono O'odham Nation Health Care Budget Amendments Table as dated**
4 **for reference July 2019 (collectively, "FY 2019 Tohono O'odham Nation Health**

6 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
7 **FY 2019 Tohono O'odham Nation Health Care Budget Amendments.**

8 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
9 **Nation chairperson or any designated official is authorized to administer and**
10 **expend the FY 2019 Tohono O'odham Nation Health Care Budgets as amended,**
11 **provided that any amendments or modifications shall be submitted for prior**
12 **approval by the Tohono O'odham Legislative Council.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 29TH**
14 **day of JULY, 2019 at a meeting at which a quorum was present with a vote of 3,175,2 FOR -0-**
15 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
16 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
17 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat.984).**
