

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution Nos. 19-005, 19-097, and 19-199 "Approving the Monthly Age 18
Report for January, April and June 2019 of Tohono O'odham Eligible Minor
Members and Authorizing Distribution of the Per Capita Payments and
Interest Held in Trust on Their Behalf by Wells Fargo Bank")

RESOLUTION NO. 19-279

1 **WHEREAS, on June 28, 1997, the Nation's voters approved Initiative No. IN-01-97, the "Tohono**
2 **O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes**
3 **per capita payments to the Nation's members provided that sufficient gaming**
4 **revenues are available; and**

5 **WHEREAS, the Ordinance for the Regulation of Gaming Activities within the Tohono**
6 **O'odham Nation ("Gaming Ordinance") was subsequently amended to authorize**
7 **per capita distribution payments in accordance with the Initiative (Legislative**
8 **Council Resolution No. 97-303); and**

9 **WHEREAS, the Trust Agreement with Wells Fargo Bank requires that a listing of all minor**
10 **beneficiaries turning 18 that month be presented to the Tohono O'odham**
11 **Legislative Council to obtain approval to distribute the trust funds to these**
12 **eligible minor members as they are no longer restricted beneficiaries; and**

13 **WHEREAS, the Tohono O'odham Legislative Council approved the minors identified on the**
14 **Monthly Age 18 Report for January, April and June 2019 who reached the age of 18**
15 **and is no longer restricted from receiving their per capita payments in**
16 **Resolution Nos. 19-005, 19-097, and 19-199; and**

17 **WHEREAS, the Nation's Enrollment Office has identified incorrect names for members on**
18 **the Monthly Age 18 Report for January, April and June 2019; and**

19 **WHEREAS, the Nation's Enrollment Office recommends that the names of the members be**
20 **amended on the Monthly Age 18 Report for January, April and June 2019.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
22 **amends Resolution Nos. 19-005, 19-097, and 19-199, "Approving the Monthly Age**
23 **18 Report for January, April and June 2019 of Tohono O'odham Eligible Minor**
24 **Members and Authorizing Distribution of the Per Capita Payments and Interest**
25 **Held in Trust on Their Behalf by Wells Fargo Bank", to reflect the correct name of**
26 **the member in accordance with the attached Monthly Age 18 Report Amendment**
27 **August 2019.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
29 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Sections 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
32 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
34 **18, 1934 (48 Stat.984).**
