

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Legislative Branch Budget Amendment No. 2)**

**RESOLUTION NO. 19-283**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Legislative Branch Budget in the amount of \$3,920,926.02 was**  
8 **approved by Resolution No. 18-298 and subsequently amended by Resolution No.**  
9 **19-169, which did not change the overall budget amount; and**

10 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its FY**  
11 **2019 Legislative Branch Budget Amendment No. 2, which is incorporated by this**  
12 **reference and which will adjust operational and/or personnel line items; and**

13 **WHEREAS, the FY 2019 Legislative Branch Budget Amendment No. 2 will increase the FY 2019**  
14 **Legislative Branch Budget by \$156,992.29 from \$3,920,926.02 to \$4,077,918.31;**  
15 **and**

16 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 Legislative Branch**  
17 **Budget Amendment No. 2 and recommends its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
19 **FY 2019 Legislative Branch Budget Amendment No. 2, which includes a**  
20 **\$156,992.29 increase from \$3,920,926.02 to \$4,077,918.31 that shall be funded by**  
21 **the Nation's general fund.**


22 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
23 **Legislative Council chairperson or any designated official is authorized to**  
24 **administer and expend the FY 2019 Legislative Branch Budget as amended,**  
25 **provided that any modifications shall be submitted to the Budget and Finance**  
26 **Committee for approval on behalf of the Legislative Council and amendments**  
27 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
29 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 2,134.95 FOR;**  
30 **776.25 AGAINST; 264.5[02] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**  
31 **Council by Article VI, Sections 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation,**  
32 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
33 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
34 **Act of June 18, 1934 (48 Stat.984).**
