

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Revenue Projection of the Tohono O'odham Nation)**

RESOLUTION NO. 19-297

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to manage any**
2 **funds within the exclusive control of the Tohono O'odham Nation" (Constitution**
3 **of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**

4 **WHEREAS, the Nation's Treasurer has calculated that \$104,466,235.89 is the projected**
5 **amount needed to fund the Nation's FY 2020 General Fund Budgets for the**
6 **Executive, Legislative, and Judicial Branches; and**

7 **WHEREAS, the Budget and Finance Committee and the Executive Office have reviewed the FY**
8 **2020 Revenue Projection, which is incorporated by this reference; and**

9 **WHEREAS, the Budget and Finance Committee and the Executive Office recommend the**
10 **adoption of the FY 2020 Revenue Projection in the amount of \$104,466,235.89 to**
11 **fund the Nation's FY 2020 General Fund Budgets.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it approves**
13 **the FY 2020 Revenue Projection in the amount of \$104,466,235.89 for the purpose**
14 **of funding the Nation's FY 2020 General Fund Budgets.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
16 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
18 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
19 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat.984).**
