

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2020 Legislative Branch Budget)**

**RESOLUTION NO. 19-298**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its FY**  
8 **2020 Legislative Branch Budget, which is incorporated by this reference, in the**  
9 **amount of \$4,839,203.53 to be funded from the Nation's general fund; and**


10 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2020 Legislative Branch**  
11 **Budget and recommends its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
13 **FY 2020 Legislative Branch Budget effective October 1, 2019 in the amount of**  
14 **\$4,839,203.53, that includes the cost of living adjustment ("COLA") per the FY 2020**  
15 **Budget Instructions for all employees and elected officials, which shall be funded**  
16 **by the Nation's general fund.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
18 **Legislative Council chairperson or any designated official is authorized to**  
19 **administer and expend the FY 2020 Legislative Branch Budget, provided that any**  
20 **modifications shall be submitted to the Budget and Finance Committee for**  
21 **approval on behalf of the Legislative Council and amendments shall be submitted**  
22 **for prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>th</sup>**  
24 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 2,628.6 FOR; 547.1**  
25 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
29 **18, 1934 (48 Stat.984).**
