

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Natural Resources Solid Waste Management
Program Revenue Funding Budget)

RESOLUTION NO. 19-303

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Natural Resources has prepared and submitted for review and**
8 **approval its FY 2020 Solid Waste Management Program Revenue Funding Budget,**
9 **which is incorporated by this reference, in the amount of \$2,087,057.39 of which**
10 **\$1,677,057.39 is to be funded from the Nation's general fund, and \$410,000.00 is**
11 **funded from program revenue; and**


12 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**
13 **have reviewed the FY 2020 Department of Natural Resources Solid Waste**
14 **Management Program Revenue Funding Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **FY 2020 Department of Natural Resources Solid Waste Management Program**
17 **Revenue Funding Budget effective October 1, 2019 in the amount of \$410,000.00,**
18 **which shall be funded from program revenue.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
20 **Nation chairperson or any designated official is authorized to administer and**
21 **expend the FY 2020 Department of Natural Resources Solid Waste Management**
22 **Program Revenue Funding Budget, provided that any amendments or**
23 **modifications shall be submitted for prior approval by the Tohono O'odham**
24 **Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
26 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,057.9 FOR; 117.8**
27 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**
