

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Planning Department Realty Program Land Acquisition Budget)

RESOLUTION NO. 19-320

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Planning Department has prepared and submitted for review and approval
8 its FY 2020 Realty Program Land Acquisition Budget, which is incorporated by this
9 reference in the amount of \$330,000.00 to be funded from the Nation's Land
10 Acquisition fund; and


11 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
12 have reviewed the FY 2020 Planning Department Realty Program Land
13 Acquisition Budget and recommend its approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
15 FY 2020 Planning Department Realty Program Land Acquisition Budget in the
16 amount of \$330,000.00, which shall be funded by the Nation's Land Acquisition
17 fund.

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
19 Nation chairperson or any designated official is authorized to administer and
20 expend the FY 2020 Planning Department Realty Program Land Acquisition
21 Budget, provided that any amendments or modifications shall be submitted for
22 prior approval by the Tohono O'odham Legislative Council.

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
24 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
26 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
27 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat.984).**


