

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Tohono O'odham Nation Health Care Budgets)

RESOLUTION NO. 19-322

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation Health Care ("TONHC") Governing Body, subject to
8 the review and approval by oversight committees and Legislative Council, was
9 delegated the authority to review and approve all TONHC budgets and budgets
10 expending health self-governance funds, including budgets expending such
11 funds for supporting programs with other Nation's departments (Tohono
12 O'odham Nation Health Care Governing Body Bylaws, Section 9403 (A)); and

13 **WHEREAS,** the Tohono O'odham Nation Health Care, Department of Public Safety-Health
14 Care Center Security, Department of Information and Technology, Facility
15 Management Program, and Planning and Economic Development Department
16 have prepared and submitted for review and approval the FY 2020 Tohono
17 O'odham Nation Health Care Budgets for the period beginning October 1, 2019
18 and ending on September 30, 2020 (collectively, "FY 2020 Tohono O'odham Nation
19 Health Care Budgets"), and as identified in FY 2020 Tohono O'odham Nation
20 Health Care Budgets Schedule, which is attached and incorporated by this
21 reference, in the total amount of \$141,654,044.39; and

29 **WHEREAS,** the Governing Body, pursuant to the Governing Body Bylaws at Article III, Section
30 9401(d) and the CMS conditions of participation found at 42 CFR Part 482(d)(1), is
31 legally responsible for an institutional plan that "must include an annual
32 operating budget that includes all anticipated income and expenses"; and

33 **WHEREAS,** the TONHC Governing Body has reviewed the FY 2020 Tohono O'odham Nation
34 Health Care Budgets and recommends approval; and

1 **WHEREAS, the Health and Human Services and Budget and Finance Committees of the**
2 **Legislative Council have reviewed the FY 2020 Tohono O'odham Nation Health**
3 **Care Budgets and recommend approval.**

4 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
5 **FY 2020 Tohono O'odham Nation Health Care Budgets effective October 1, 2019 in**
6 **the total amount of \$141,654,044.39 which shall be funded by the Indian Health**
7 **Service and third party revenues.**

8 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
9 **Nation chairperson or any designated official is authorized to administer and**
10 **expend the FY 2020 Tohono O'odham Nation Health Care Budgets, provided, that**
11 **the Governing Body shall approve any amendments or modifications, subject to**
12 **final approval by the Tohono O'odham Legislative Council.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH**
14 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 1,613.8 FOR;**
15 **1,561.9 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**
16 **by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted**
17 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
18 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
19 **Act of June 18, 1934 (48 Stat.984).**
