

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Health and Human Services Self-Governance Budgets)

RESOLUTION NO. 19-324

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2020 Self-Governance Budgets for the period
9 beginning October 1, 2019 and ending on September 30, 2020 (collectively, "FY
10 2020 Department of Health and Human Services Self-Governance Budgets"),
11 which are provided below and incorporated by this reference, in the total amount
12 of \$6,881,864.40 to be funded by the Self-Governance Funding Agreement; and

13 **WHEREAS,** the following base budgets in the amount of \$6,881,864.40 have been prepared as
14 follows:

22 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
23 reviewed the FY 2020 Department of Health and Human Services Self-Governance
24 Budgets and recommend their approval.

25 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
26 FY 2020 Department of Health and Human Services Self-Governance Budgets
27 effective October 1, 2019 in the total amount of \$6,881,864.40, which shall be
28 funded by the Self-Governance Funding Agreement.

29 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the Tohono
30 O'odham Nation chairperson or any designated official is authorized to negotiate
31 and execute amendments to the Self-Governance Funding Agreement with the
32 Indian Health Service for the maximum allowable funding.

33 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
34 Nation chairperson or any designated official is authorized to administer and
35 expend the FY 2020 Department of Health and Human Services Self-Governance

Budgets, provided that any amendments or modifications shall be submitted for prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
