

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Health and Human Services Division of
Health Transportation Service Budget Program Revenue Funding)

RESOLUTION NO. 19-325

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2020 Division of Health Transportation Service Budget,
9 which is incorporated by this reference, in the amount of \$3,974,567.00, of which
10 \$2,354,567.00 is to be funded from the Nation's general fund, \$1,500,000.00 is
11 funded from program revenue, and \$120,000.00 is funded from miscellaneous
12 revenues; and

13 **WHEREAS,** the portion of the FY 2020 Department of Health and Human Services Division of
14 Health Transportation Budget funded by the Nation's general fund is addressed
15 by separate resolution; and

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
17 reviewed the FY 2020 Department of Health and Human Services Division of
18 Health Transportation Service Budget program revenue funding and
19 recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
21 **FY 2020 Department of Health and Human Services Division of Health**
22 **Transportation Service Budget program revenue funding effective October 1,**
23 **2019 in the amount of \$1,500,000.00, which shall be funded by Health**
24 **Transportation Service program and miscellaneous revenue and \$120,000.00**
25 **which shall be funded by miscellaneous revenue.**

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
27 **Nation chairperson or any designated official is authorized to administer and**
28 **expend the FY 2020 Department of Health and Human Services Division of Health**
29 **Transportation Service Budget program revenue funding, provided that any**
30 **amendments or modifications shall be submitted for prior approval by the**
31 **Tohono O'odham Legislative Council.**
