

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Health and Human Services Division of Behavioral Health Tas Tonlik Ki Program Budget)

RESOLUTION NO. 19-327

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2020 Division of Behavioral Health Tas Tonlik Ki
9 Program Budget, which is incorporated by this reference, in the amount of
10 \$1,540,978.00 to be funded from program revenues; and


11 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
12 reviewed the FY 2020 Department of Health and Human Services Division of
13 Behavioral Health Tas Tonlik Ki Program Budget and recommend its approval.

14 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
15 FY 2020 Department of Health and Human Services Division of Behavioral Health
16 Tas Tonlik Ki Program Budget, effective October 1, 2019 in the amount of
17 \$1,540,978.00, which shall be funded by program revenues.

18 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
19 Nation chairperson or any designated official is authorized to administer and
20 expend the FY 2020 Department of Health and Human Services Division of
21 Behavioral Health Tas Tonlik Ki Program Budget, provided that any amendments
22 or modifications shall be submitted for prior approval by the Tohono O'odham
23 Legislative Council.

24 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14th
25 day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
26 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
27 Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by
28 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
29 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
30 18, 1934 (48 Stat.984).
