

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2020 Department of Health and Human Services Division of Behavioral Health Indian Health Service Methamphetamine Suicide Prevention Initiative Budget)**

**RESOLUTION NO. 19-330**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Tohono O'odham Nation received an award notice in the amount of  
8 \$176,150.00 for year five of a five-year funding cycle for budget period September  
9 30, 2019 through September 29, 2020; and

10 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
11 review and approval its FY 2020 Division of Behavioral Health Indian Health  
12 Service Methamphetamine Suicide Prevention Initiative Budget in the amount of  
13 \$176,150.00, which is incorporated by this reference, which shall be funded by the  
14 Nation's general fund pending reimbursement from the grantor, the Indian  
15 Health Service; and

16 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
17 reviewed the FY 2020 Department of Health and Human Services Division of  
18 Behavioral Health Indian Health Service Methamphetamine Suicide Prevention  
19 Initiative Budget and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
21 FY 2020 Department of Health and Human Services Division of Behavioral Health  
22 Indian Health Service Methamphetamine Suicide Prevention Initiative Budget  
23 effective September 30, 2019 in the amount of \$176,150.00, which shall be funded  
24 by the Nation's general fund pending reimbursement from the grantor, the  
25 Indian Health Service.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
27 Nation chairperson or any designated official is authorized to administer  
28 and expend the FY 2020 Department of Health and Human Services Division of  
29 Behavioral Health Indian Health Service Methamphetamine Suicide Prevention  
30 Initiative Budget, provided that any amendments or modifications shall be  
31 submitted for prior approval by the Tohono O'odham Legislative Council.
