

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2020 Department of Health and Human Services Division of**  
**Community Health Services Third Party Revenue Budget)**

**RESOLUTION NO. 19-333**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for  
8 review and approval its FY 2020 Division of Community Health Services Third  
9 Party Revenue Budget, which is incorporated by this reference, in the amount of  
10 \$36,500.00 to be funded from the State of Arizona Health Care Cost Containment  
11 Systems ("AHCCCS") collections and CPR/AED/First Aid training fees; and

12 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have  
13 reviewed the FY 2020 Department of Health and Human Services Division of  
14 Community Health Services Third Party Revenue Budget and recommend its  
15 approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
17 FY 2020 Department of Health and Human Services Division of Community Health  
18 Services Third Party Revenue Budget, effective October 1, 2019 in the amount of  
19 \$36,500.00, which shall be funded by AHCCCS collections and CPR/AED/First Aid  
20 training fees.

21 **BE IT FURTHER RESOLVED** that the Tohono O'odham Legislative Council authorizes any  
22 unexpended Division of Community Health Services third party billing revenue  
23 be made available for appropriation to the Division of Community Health  
24 Services in future fiscal years in accordance with a budget approved by  
25 Legislative Council resolution.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
27 Nation chairperson or any designated official is authorized to administer and  
28 expend the FY 2020 Department of Health and Human Services Division of  
29 Community Health Services Third Party Revenue Budget, provided that any  
30 amendments or modifications shall be submitted for prior approval by the  
31 Tohono O'odham Legislative Council.
