

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Department of Health and Human Services Food
Distribution Program USDA Nutrition Education Budget)

RESOLUTION NO. 19-337

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Department of Health and Human Services has prepared and submitted for
8 review and approval its FY 2020 Food Distribution Program United States
9 Department of Agriculture ("USDA") Nutrition Education Budget, which is
10 incorporated by this reference, in the amount of \$2,000.00 to be funded by the
11 Nation's general fund pending reimbursement from the grantor, the USDA; and

12 **WHEREAS,** the Health and Human Services and Budget and Finance Committees have
13 reviewed the FY 2020 Department of Health and Human Services Food
14 Distribution Program USDA Nutrition Education Budget and recommend its
15 approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
17 FY 2020 Department of Health and Human Services Food Distribution Program
18 USDA Nutrition Education Budget effective October 1, 2019 in the amount of
19 \$2,000.00, which shall be funded by the Nation's general fund pending
20 reimbursement from the grantor, the USDA.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
22 Nation chairperson or any designated official is authorized to administer and
23 expend the FY 2020 Department of Health and Human Services Food Distribution
24 Program USDA Nutrition Education Budget, provided that any amendments or
25 modifications shall be submitted for prior approval by the Tohono O'odham
26 Legislative Council.

27 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH
28 day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
29 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
30 Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by
31 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
32 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
33 18, 1934 (48 Stat.984).
