

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Planning and Economic Development Department Roads
Program Project PIR 31 Cowlic Road Budget)**

RESOLUTION NO. 19-339

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Planning and Economic Development Department has prepared and
8 submitted for review and approval its FY 2020 Roads Program Project PIR 31
9 Cowlic Road Budget, which is incorporated by this reference in the amount of
10 \$1,150,103.61, which shall be funded by the Nation's general fund pending
11 reimbursement by the grantor, the Bureau of Indian Affairs; and

12 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees
13 have reviewed the FY 2020 Planning and Economic Development Department
14 Roads Program Project PIR 31 Cowlic Road Budget and recommend its approval.

15 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
16 FY 2020 Planning and Economic Development Department Roads Program
17 Project PIR 31 Cowlic Road Budget effective October 1, 2019 in the amount of
18 \$1,150,103.61, which shall be funded by the Nation's general fund pending
19 reimbursement by the grantor, the Bureau of Indian Affairs.

20 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
21 Nation chairperson or any designated official is authorized to administer and
22 expend the FY 2020 Planning and Economic Development Department Roads
23 Program Project PIR 31 Cowlic Road Budget, provided that any amendments or
24 modifications shall be submitted for prior approval by the Tohono O'odham
25 Legislative Council.

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH**
27 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
29 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
30 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**
