

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2020 Planning and Economic Development Department Roads Program**  
**Project PIR 21(4) Santa Cruz to Papago Farms Budget)**

RESOLUTION NO. 19-342

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Planning and Economic Development Department has prepared and**  
8 **submitted for review and approval its FY 2020 Roads Program Project PIR 21(4)**  
9 **Santa Cruz to Papago Farms Budget, which is incorporated by this reference, in**  
10 **the amount of \$8,444,000.00 to be funded from the Nation's general fund pending**  
11 **reimbursement from the Bureau of Indian Affairs; and**

12 **WHEREAS, the Agricultural and Natural Resources and Budget and Finance Committees**  
13 **have reviewed the FY 2020 Planning and Economic Development Department**  
14 **Roads Program Project PIR 21(4) Santa Cruz to Papago Farms Budget and**  
15 **recommend its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
17 **FY 2020 Planning and Economic Development Department Roads Program**  
18 **Project PIR 21(4) Santa Cruz to Papago Farms Budget effective October 1, 2019 in**  
19 **the amount of \$8,444,000.00, which shall be funded by the Nation's general fund**  
20 **pending reimbursement from the Bureau of Indian Affairs.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
22 **Nation chairperson or any designated official is authorized to administer and**  
23 **expend the FY 2020 Planning and Economic Development Department Roads**  
24 **Program Project PIR 21(4) Santa Cruz to Papago Farms Budget, provided that any**  
25 **amendments or modifications shall be submitted for prior approval by the**  
26 **Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>**  
28 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat.984).**
