

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Planning and Economic Development Department Sells
Alternative Rural Health Center Facility Budget)

RESOLUTION NO. 19-343

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate
3 these funds for the benefit of the nation and its members" provided that "[a]ll
4 expenditures of these funds shall be pursuant to appropriations or budgets"
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** by Resolution No. 19-180, the Legislative Council authorized the Nation's
8 chairperson to enter into a P.L. 93-638 Title V Construction Contract Project
9 Agreement with Indian Health Service for the planning phase of the new Sells
10 Alternative Rural Health Center Facility; and

11 **WHEREAS,** the Planning and Economic Development Department has prepared and
12 submitted for review and approval its FY 2020 Sells Alternative Rural Health
13 Center Facility Budget, which is incorporated by this reference, in the amount of
14 \$359,986.00 to be funded by the Indian Health Service; and

15 **WHEREAS,** the Agricultural and Natural Resources, Health and Human Services, and Budget
16 and Finance Committees have reviewed the FY 2020 Planning and Economic
17 Development Department Sells Alternative Rural Health Center Facility Budget
18 and recommend its approval.

19 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
20 FY 2020 Planning and Economic Development Department Sells Alternative Rural
21 Health Center Facility Budget effective October 1, 2019 in the amount of
22 \$359,986.00, which shall be funded by the Indian Health Services.

23 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
24 Nation chairperson or any designated official is authorized to administer and
25 expend the FY 2020 Planning and Economic Development Department Sells
26 Alternative Rural Health Center Budget, provided that any amendments or
27 modifications shall be submitted for prior approval by the Tohono O'odham
28 Legislative Council.

29 **The foregoing Resolution** was passed by the Tohono O'odham Legislative Council on the 14TH
30 day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-
31 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
32 Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by
33 the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
34 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
35 18, 1934 (48 Stat.984).
