

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2020 Planning and Economic Development Department Roads  
Program Road Safety Assessment IR 19)**

**RESOLUTION NO. 19-344**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the Planning and Economic Development Department has prepared and  
8 submitted for review and approval its FY 2020 Roads Program Road Safety  
9 Assessment IR 19 Budget, which is incorporated by this reference, in the amount  
10 of \$99,974.46 to be funded from Nation's general fund pending reimbursement  
11 from the Bureau of Indian Affairs; and

12 **WHEREAS,** the Agricultural and Natural Resources and Budget and Finance Committees  
13 have reviewed the FY 2020 Planning and Economic Development Department  
14 Roads Program Road Safety Assessment IR 19 Budget and recommend its  
15 approval.

16 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
17 FY 2020 Planning and Economic Development Department Roads Program Road  
18 Safety Assessment IR 19 Budget effective October 1, 2019 in the amount of  
19 \$99,974.46, which shall be funded by the Nation's general fund pending  
20 reimbursement from the Bureau of Indian Affairs.

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
22 Nation chairperson or any designated official is authorized to administer and  
23 expend the FY 2020 Planning and Economic Development Department Roads  
24 Program Road Safety Assessment IR 19 Budget, provided that any amendments or  
25 modifications shall be submitted for prior approval by the Tohono O'odham  
26 Legislative Council.

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>**  
28 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,125.7 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
30 **Article VI, Section 1(d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
31 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat.984).**
