

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Baboquivari District Budgets)**

RESOLUTION NO. 19-347

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS,** by Baboquivari District Council Resolution No. 2019-B-66, the Baboquivari
13 **District has authorized the FY 2020 Baboquivari District Budgets, which are**
14 **incorporated by this reference, in the amount of \$5,804,638.14; and**

15 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Baboquivari District
16 **Budgets and recommends approval.**

17 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
18 **FY 2020 Baboquivari District Budgets in the amount of \$5,804,638.14, which shall**
19 **be funded by the FY 2020 district gaming allocation in the amount of \$5,199,822.31**
20 **and the FY 2019 carry forward funding in the amount of \$604,755.83.**

21 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020
22 **Baboquivari District Budgets shall be managed and expended in accordance with**
23 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation and the**
24 **Nation's laws, provided that any amendments or modifications shall be**
25 **authorized under District Council resolution and submitted for prior approval by**
26 **the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND**
28 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
30 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
