

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2020 Chukut Kuk District Budget)**

**RESOLUTION NO. 19-352**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only by**  
6 **a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice chairman of the district council.**

11 **; and**

12 **WHEREAS, by Chukut Kuk District Council Resolution No. 2019-39, the Chukut Kuk District**  
13 **has authorized the FY 2020 Chukut Kuk District Budget, which is incorporated by**  
14 **this reference, in the amount of \$2,129,448.90; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2020 Chukut Kuk District**  
16 **Budget and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2020 Chukut Kuk District Budget in the amount of \$2,129,448.90, which**  
19 **includes funding from:**

- 20 **1. FY 2020 district gaming allocation in the amount of \$2,094,672.37;**
- 21 **2. FY 2017 Surplus Funds in the amount of \$9,926.51;**
- 22 **3. FY 2016 Mining Allocation in the amount of \$13,067.44; and**
- 23 **4. FY 2014 Mining Allocation in the amount of \$11,782.58.**

24 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it authorizes the**  
25 **transfer of the remaining balance of the FY 2020 district gaming allocation in the**  
26 **amount of \$2,601,167.30 to the Chukut Kuk District's account, provided that any**  
27 **expenditure of the funds is not authorized until a budget is authorized by the**  
28 **district council and approved by the Tohono O'odham Legislative Council.**

29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2020 Chukut**  
30 **Kuk District Budget shall be managed and expended in accordance with Article**  
31 **IX, Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's**  
32 **laws, provided that any amendments or modifications shall be authorized under**  
33 **District Council resolution and submitted for prior approval by the Tohono**  
34 **O'odham Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22<sup>ND</sup> day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
