

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2020 HICKIWAN DISTRICT BUDGETS)

RESOLUTION NO. 19-353

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**
4 **authorized under resolutions of the district council and approved by the**
5 **Tohono O'odham Council. The management of these funds shall be only by**
6 **a treasurer or other authorized officer of the district council who has**
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**
8 **O'odham Nation, and all expenditures of these funds shall be by checks**
9 **signed by such treasurer or other authorized officer and the chairman or**
10 **vice chairman of the district council.**

12 **WHEREAS, by HICKIWAN District Council Resolution HDC-19-049, the HICKIWAN District has**
13 **authorized the FY 2020 HICKIWAN District Budgets, which are incorporated by this**
14 **reference in the amount of \$2,913,107.01; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2020 HICKIWAN District**
16 **Budgets and recommends approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2020 HICKIWAN District Budgets in the amount of \$2,913,107.01, which shall be**
19 **funded by the FY 2020 district gaming allocation.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2020 HICKIWAN**
21 **District Budgets shall be managed and expended in accordance with Article IX,**
22 **Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws,**
23 **provided that any amendments or modifications shall be authorized under**
24 **District Council resolution and submitted for prior approval by the Tohono**
25 **O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND**
27 **day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175.7 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by**
29 **Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
30 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
