

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2020 Sif-Oidak District Gaming Revenue Budget)**

RESOLUTION NO. 19-355

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham
2 Nation,

3 No district council shall expend district funds except pursuant to budgets
4 authorized under resolutions of the district council and approved by the
5 Tohono O'odham Council. The management of these funds shall be only by
6 a treasurer or other authorized officer of the district council who has
7 furnished a surety bond satisfactory to the treasurer of the Tohono
8 O'odham Nation, and all expenditures of these funds shall be by checks
9 signed by such treasurer or other authorized officer and the chairman or
10 vice chairman of the district council.

12 **WHEREAS,** by Sif-Oidak District Council Resolution No. 19-142 and Resolution No. 19-160, the
13 Sif-Oidak District Council has authorized the FY 2020 Sif-Oidak District Gaming
14 Revenue Budget, which is incorporated by this reference in the amount of
15 \$2,958,976.82; and

16 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2020 Sif-Oidak District
17 Gaming Revenue Budget and recommends its approval.

18 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the
19 FY 2020 Sif-Oidak District Gaming Revenue Budget in the amount of
20 \$2,958,976.82, which shall be funded by the FY 2020 district gaming allocation.

21 **BE IT FURTHER RESOLVED** by the Tohono O'odham Legislative Council that the remaining
22 balance of the FY 2020 Sif-Oidak District gaming allocation of \$345,002.46 shall
23 remain with the Tohono O'odham Nation until a budget has been authorized by
24 the Sif-Oidak District Council and approved by the Tohono O'odham Legislative
25 Council.

26 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2020 Sif-Oidak
27 District Gaming Revenue Budget as approved shall be managed and expended in
28 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham
29 Nation and the Nation's laws, provided that any amendments or modifications
30 shall be authorized under District Council resolution and submitted for prior
31 approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 22ND day of AUGUST, 2019 at a meeting at which a quorum was present with a vote of 3,175,7 FOR; -0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
